The Office of the Attorney General is seeking qualified candidates for a Detective Supervisor position in New York City. Candidates should be hard-working, motivated, and committed to public service on behalf of the people of the State of New York.

Detective Supervisors oversee investigations of the circumstances, facts and conditions connected with complaints and violations of the law, using the highest level of independent judgment and discretion to ensure the integrity, thoroughness, and fairness of investigations. This position is assigned to the Dignitary Protection Detail for the Attorney General.

**Minimum Qualifications:**

- At least ten (10) years of prior law enforcement experience.
- Current New York State Basic Police Academy certification approved by the Division of Criminal Justice Services (DCJS), or the ability to successfully complete all requirements to obtain such certification.
- Demonstrated expertise in threat assessment, protective intelligence, logistical security planning, advance work, route planning, secure transportation, and risk mitigation.
- Experience and training in surveillance, counter-surveillance, and behavioral observation/suspicious activity recognition from a recognized program or equivalent.
- Formal training and certification in Dignitary/Executive Protection from a recognized program or equivalent.
- Extensive experience facilitating coordination and interactions with multiple law enforcement agencies at federal, state, and local levels, including established professional contacts within the greater New York City metropolitan area law enforcement community.
- Strong background leading team-based operations in high-stakes, dynamic environments.
- Experience conducting criminal investigations.
- Experience interviewing witnesses, evaluating crime scenes, and collecting/preserving evidence.
- Exceptional communication, interpersonal, and team-building skills, with demonstrated commitment to fostering collaborative, inclusive, and diverse team environments.
- Unwavering professionalism, personal integrity, and ability to uphold the highest levels of confidentiality and ethical standards.
- Experience in demonstrating proper tactics and sound judgement in unpredictable environments.
- Valid New York State Driver's License with a clean record and ability to safely operate a motor vehicle.
- U.S. citizenship and residency in New York State, as required by the Public Officer's Law for police officers at the OAG.

**Preferred Qualifications:**

- Three (3) years of frontline supervisory experience leading police officers and/or detectives in law enforcement including supervising teams of eight (8) or more personnel.
- Four (4) years of consistent daily executive/dignitary protection experience, including conducting protective operations for high-level officials, executives, dignitaries, or similar public/private protectees.
- Proven ability to respond effectively to high-pressure, unpredictable situations while maintaining composure, professionalism, and clear communication.
- Resilient, adaptable mindset with the capacity to thrive in high-stakes settings; recover swiftly from challenges; balance urgency with calm decision-making; and model emotional discipline, integrity, and emotional intelligence for the team.

**The annual salary for this position is \$108,478. Appointments in New York City receive an additional \$4,000 location pay.** Performance of the duties may require frequent, unscheduled work on evenings and weekends and requires 24/7 availability. This position is in the exempt class, and incumbents serve at the pleasure of the Attorney General.
